WORKING WITHIN THE CONSTITUTIONAL FRAMEWORK: LIBRARIES AND LIBRARIANS' RIGHTS AND DUTIES

ELLEN CREAGAR, LIBRARY BOARD CHAIRMAN

Libraries play a crucial role in safeguarding and promoting fundamental rights: serving as bastions of intellectual freedom, fostering access to information, encouraging democratic participation, and protecting individuals' rights to privacy, confidentiality, and free speech.



Constitutional rights

- The beginning of the Wyoming Constitution contains the following phrases: *All power is inherent in the people and In their inherent right to life, liberty, and the pursuit of happiness, all members of the human race are equal.*
- The First Amendment to the U.S. Constitution guarantees all individuals the right to express their ideas without governmental interference, and to read and listen to the ideas of others.
- A public library's materials provide its users with the necessary information and ideas to access, learn, communicate, and enjoy.

Forums for Free Speech

- Wyoming citizens have the fundamental right to free and open access to information and ideas.
- Access to informational and creative materials must be available without cost barriers, censorship, bias, or fear of repercussion.
- Individuals have the right to form opinions about resources they choose to read, view, listen to, or otherwise access.
- Libraries do not advocate the ideas found in their collections or in resources accessible through the library.

Promoters of Intellectual Freedom

- The library has the duty to ensure access to the broadest range of materials, from a variety of viewpoints, reflecting the interests and demographics of the community.
- Libraries should not prevent access to information because of the background or views of an author, nor should they tolerate government, group, or individual attempts to reduce or deny access to public information.

Protectors of Privacy and Confidentiality

- Privacy is essential to the exercise of free speech, free thought, and free association.
- Regarding libraries, the right to privacy is the right to open inquiry without having the subject of one's interest examined or scrutinized by others.
- Confidentiality exists when a library is in possession of personally identifiable information about users and keeps that information private on their behalf.

Protecting user privacy and confidentiality has long been an integral part of the mission of libraries.

What this means for you?

- You have the freedom to access information and materials of your choice and to have that access kept confidential.
- You have the right to use the library without discrimination or threat of harm, invasion of property, or interference.
- The library will protect and honor your Constitutional rights.


